### Job Training Grant

EPA has selected Groundwork Elizabeth for a Brownfields Job Training Grant. Groundwork Elizabeth plans to train 75 students and place 40 in environmental jobs. The training program includes 168 hours of instructional training, as detailed in the chart below. Students who complete the training will earn up to four federal certifications.

Groundwork Elizabeth is targeting youth aged 16-24 who are unemployed or underemployed residents in public housing or from the Youth Corp program. Key partners include the American Red Cross, Climate Change Mitigation Technologies, Curt Collier, Friends of Great Swamp, the Housing Authority of the City of Elizabeth Jobs Plus University Program, the Kean University Department of Environmental Science and Sustainability, the New Jersey Apprenticeship Network, New Jersey Fish and Wildlife, the New Jersey Tree Academy, New Jersey Youth Corps, the New Jersey Institute of Technology Technical Assistance to Brownfield Communities, One-Stop Career Centers, United Way of Greater Union County, and Viridian Environmental Consultants.

## Overview of the EPA Brownfields Program

EPA's Brownfields Program empowers states, Tribal Nations, communities, and other stakeholders to work together to prevent, assess, safely clean up, and sustainably reuse brownfields. A brownfield site is real property, the expansion, redevelopment, or reuse of which may be complicated by the presence or potential presence of a hazardous substance, pollutant, or contaminant. The Small Business Liability Relief and Brownfields Revitalization Act of 2002, as amended by the Brownfields Utilization, Investment and Local Development Act of 2018, was passed to help states, Tribal Nations, and communities around the country clean up and revitalize brownfield sites. Under this law, EPA provides financial assistance to eligible applicants through five competitive grant programs: Multipurpose Grants, Assessment Grants, Revolving Loan Fund Grants, Cleanup Grants, and Brownfields Job Training Grants. Additionally, funding support is provided to state and tribal response programs through a separate mechanism.

Brownfields Job Training Grant funds are provided to nonprofit organizations and other eligible entities to recruit and train unemployed and underemployed residents from communities affected by environmental pollution, economic disinvestment, and brownfields and place them in environmental jobs. Since the program was created in 1998, EPA has awarded 430 job training grants totaling over \$113.1 million through Brownfield Job Training Programs. With these grants, approximately 23,460

individuals have completed training and over 17,450 individuals have been placed in careers related to land remediation and environmental health and safety. This equates to a cumulative placement rate of approximately 74 percent. The average starting wage for these jobs over the last five years is approximately \$23 an hour.
